6. ADDITIONAL CONDITIONS UNDER WHICH A PERMIT CAN BE GRANTED:

1. *The permit is valid for a period of three months.*
2. *The applicant must be over 15 years of age.*
3. *The maximum transmit power is 1000Watts for the bands below 30MHz and 150Watts for bands above 50MHz.*
