### Quadripartite Frequency Coordination Meeting

Anguilla

June 8-10, 2016

#### CONCLUSIONS

We, the Representatives of the Telecommunications Administrations and/or Regulators of Anguilla, France, Sint Maarten and the State of Netherlands for Saba and Sint Eustatius having met in Anguilla on June 8-10 2016 at the 2016 Quadripartite Frequency Coordination Meeting with the support of our respective governments have made the following Agreements and conclusions:

1. The representatives of the Administrations of Anguilla (AIA), France (F), Saba (BES), St. Eustatius (BES), and St. Maarten (SXM), taking into account the recommendations of the International Telecommunication Union, have concluded that Anguilla will develop and submit a proposal for consideration by the quadripartite group for the use of sound broadcasting in Anguilla in the spectrum range 76-88 MHz. **(Agenda Item # 4)**
2. The representatives of the Administrations of Anguilla (AIA), France (F), Saba (BES), St. Eustatius (BES), and St. Maarten (SXM), taking into account the recommendations of the International Telecommunication Union, have concluded an Agreement, under Article 6 of the Radio Regulations, on the coordination of frequencies used by sound broadcasting in the spectrum range 88-108 MHz. **(Agenda Item # 5)**
3. The representatives of the Administrations of Anguilla (AIA), France (F) and the Netherland Antilles (ATN), taking into account the recommendations of the International Telecommunication Union, have concluded an Agreement, under Article 6 of the Radio Regulations, on the coordination of frequencies used by broadcasting and mobile radio communication networks in the spectrum range 470 MHz to 694 MHz. **(Agenda Item # 6)**

4. The representatives of the Administrations of Anguilla (AIA), France (F), St Maarten (SXM) and the State of the Netherlands for Saba and St. Eustatius (BES), taking into account the recommendations of the International Telecommunication Union, have concluded an actual Agreement with scenarios, under Article 6 of the Radio Regulations, on the coordination of frequencies used by land mobile radio communication networks in the spectrum range 694 MHz to 3600 MHz. **(Agenda Items # 7, 8, 9)**
5. The representatives of the Administrations of Anguilla (AIA), France (F), St Maarten (SXM) and the State of the Netherlands for Saba and St. Eustatius (BES), have expressed the need and have agreed to coordinate their frequency scanning activities, to maximize the gathering and sharing of information relating to the utilization of frequency use in their respective mobile industries; **(Agenda Item # 10)**
6. Following the meeting with the service providers, it was agreed that the Administrations of Anguilla (AIA), France (F), St Maarten (SXM) and the State of the Netherlands for Saba and St. Eustatius (BES) will submit the relevant information pertaining to their frequency allocations before July 1, 2016 to their service providers. The service providers will be required to return their responses to include target frequency migration plan before August 1, 2016.
7. The Administrations will exchange the individual plans of their operators before September 1, 2016 and will constitute the overall roadmap to be agreed before September 15, 2016.
